NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Repairs to the listed Hannah Empson memorial within the churchyard:

Treat encroaching vegetation with herbicide and allow to die back prior to removal.

Re-set upper northern and western steps to have slight fall away from tomb. Rake out and re-point open joints within tomb and steps.

Carry out a resin pinned repair to the eastern kerb where delaminating, re-bed and re-point dislodged kerb stones, maintaining weep holes for drainage purposes.

The works to be in accordance with the specification and schedule of works by Smith and Roper Architects, dated April 2018.
